Preference will be given to local Nala-based companies and bidders must note that this bid may be awarded to more than one bidder. Bidders must note that certain work under this bid may only be constructed using labour-based construction methods and must limit the utilization of their permanently employed personnel to key personnel and all other personal and labourers must be recruited locally.

Bidders must be registered, or must have applied for registration, or be capable of being so registered prior to submission, with the Construction Industry Development Board (CIDB) in a contractor grading designation determined in accordance with the sum tendered for a 5 CE PE class of construction work. Enterprises who have a 6 CE potentially emerging grading may also submit bids.

Acceptable bids will be evaluated by using a system that awards points on the basis of 90 points for bid price and 10 points for the meeting of specific goals. The specific procurement goals are: HDI Equity; SMME status; Job creation and Local (SA) content.

PLEASE NOTE THAT A COMPANY'S VALID ORIGINAL TAX CLEARANCE CERTIFICATE (OR IN THE CASE OF A JOINT VENTURE, OF ALL THE PARTNERS IN THE JOINT VENTURE) MUST BE SUBMITTED WITH THE BID DOCUMENT.

A compulsory site/clarification meeting will be held at Nala Local Municipality on **Wednesday, 8 April 2009** at 10:00. Prospective bidders are requested to meet on the said date and time at the Nala Municipality Offices, 8 Preller Street, Bothaville, from where they will be accompanied to the site. Bid documentation will not be available at the compulsory site meeting and the engineer will not be available for inspection purposes on any other date and time.

Bids are to be completed in accordance with the conditions and bid rules contained in the bid documents and supporting documents must be sealed and externally endorsed with the **CONTRACT NUMBER AND DESCRIPTION** and placed in the bid box on the Ground Floor, 8 Preller Street, Bothaville not later than **12:00 on Wednesday, 15 April 2009**. Bids will be opened immediately thereafter, in public, in the Council Chambers, 8 Preller Street, Bothaville. **All bids shall hold good for 90 days as from the closing date of bids.**

Bids which are not received and/or deposited in the specified bid box before **12:00** on the closing date for the bid mentioned hereinbefore, will be marked as late bid and such bids shall, in terms of the **SCM Policy of the NALA LOCAL MUNICIPALITY**, not be considered by the NLM as valid bids.
